OCRRA Welcomes Commercial Customers Only to Rock Cut Road Transfer Station in Phases throughout June and July
Residents continue to use Ley Creek Transfer Station until further notice

SYRACUSE, N.Y. (June 15, 2020) — OCRRA recently completed major construction on the Rock Cut Road Transfer Station in Jamesville, bringing it in full compliance with new NYSDEC regulations. The site will only serve commercial customers.

All residential customers will continue to use the Ley Creek Transfer Station in Liverpool until further notice. OCRRA is studying options for improved residential customer service.

As of June 15, all commercial haulers and small business users needing to be weighed on a scale must use the new Rock Cut Road Transfer Station as the scales at Ley Creek Transfer Station are no longer in operation.

Commercial customers that do not go over the scale, also known as “flat rate” customers, will be phased in at Rock Cut Road Transfer Station throughout July.

For all residential customers, on August 6, 2020, the Ley Creek Transfer Station schedule changes from Monday through Friday to Thursday through Saturday, adding in weekend operations to better accommodate residential customers.

To help reduce the spread of COVID-19, all customers visiting any OCRRA site must maintain a 6 foot social distance from others and masks must be worn by everyone at all times on site.
